








GLIMPSES OF NATCON- 2021

Wishing you a very Happy and Prosperous New Year 2022!

It gives me immense pleasure to pen down the Presidential Address for the first issue of IMA NEWS for the year 2022.

On behalf of Indian Medical Association, I express my gratefulness and gratitude to all the Leaders, Office Bearers, Central Council Members and IMA State Presidents & State Secretaries for making IMA NATCON-2021 a great success.

I realize that the post of National President, IMA is studded with responsibilities. I am confident that with the blessings and support of our Chief Patron Dr Ketan Desai, senior leaders and cooperation of my team, we will be able to achieve the goal for the betterment of our medical fraternity. Soon after taking over as National President, IMA, I had detailed discussion and meeting with Hon'ble Union Health Minister Shri Mansukh Mandaviya on 30th December, 2021 and resolved, intricate, issues of starting the counselling of NEET PG Students. I am delighted to say that Government considered our views and put forth the affidavit in Hon'ble Supreme Court of India accordingly.

The main issues which are boggling the mind of our medical community are regarding the inclusion of Health care in Consumer Protection Act, formation of Central Act against violence on medical professionals and their medical establishments and amendments in PC-PNDT Act.

On the occasion of Padbhar Grahan Samaroh of our team held on 31st December, 2021 at IMA Hqs., we had the unique privilege of having Shri Ashwini Kumar Chaubey, Hon'ble Union Minister of State for Consumer Affairs Forest and Environment, Govt. of India and during the Samaroh, officially as well as personally, Hon'ble Minister is conveyed to make necessary amendments in the CPA for which he had agreed to have a separate meeting with IMA to consider our views.

We will also be approaching our Hon'ble Prime Minister to solve the tangle of Mixopathy at the earliest and suggesting to form a Committee consisting of learned experts like, Dr. Vedprakash MishraDean, IMA Academic and Accreditation Board, Director AIIMS Delhi, Director PGI Chandigarh, Experts from Ayurveda and Homeopathy to recommend the way forward.

IMA participated in a Special Consultative Meeting with the Ministry of Health & Family Welfare on 11th January-2022 and a large number of IMA leaders participated in the meeting from different parts of the country and expressed their views in managing the present crisis of COVID.

Our nation is represented by a large number of rural populations. Unfortunately, health care services, either from the Government or from the Private sector are not able to reach out to the rural population and provide even basic primary services to the farmers and villagers who form the backbone of our economy. I appeal all my fellow members to reach out to the unreachable rural areas to provide basic medical services through Local Branches and also involve all local Government. Therefore, we have chosen the theme of this year "Priority in Rural Healthcare & Dignity of Profession - ग्रामीण स्वास्थय सेवा में प्राथमिकता एवं पेशे की गरिमा". This will be possible only through humane services from the local branches and active IMA members. At the end of the year, I will be able to proudly announce some achievements and progress in this regard.

Any organization runs only on the strength and vision of its leaders. Active participation in driving the Organization to newer height is the responsibility of each and every member of the Organization. I shall leave no stone unturned to bring each and every member from the remotest part of the country to get actively involved at Branch Level, State Level and at National Level activities to make IMA Flag high in the comity of the nation.

But I am confident that I and my team will try our level best to do a honest and transparent job to bring more glory and dignity to our profession by upholding the strong legacy that has been set out by them for us to tread on.

My motto is simple like that of our Hon. PM-SABKA SAATH, SAABKA VIKAS and COLLABRATION not CONFRONTATION.

Last few years IMA has definitely changed gears from being a NGO to Trade Union. Thanks to my illustrious predecesors, BRAND IMA is now a force to reckon with and is taken note of by all concerned. All law makers, Opinion makers, Media etc now always look upto what IMA has to opine on . Media on their own take cognizance of what IMA has to observe.

News of what our national, state or local IMA leaders is flashed in all types of media. We have come a long way from giving paid advertisements to extensive free media coverage. This itself is a great achievement, which stands generated because of our solidarity and commitment to cater to the cause of profession and professionals in a selfless but upright, bold and respectful manner. However, it is imperative that instead of being satisfied and contended with the present significant alteration which gives us a huge sigh of relief yet we have to move a stage ahead. From being 'reactive' we need to be 'pro active', for a simple reason that adds creative credence and turns out to be significantly cognizable ensuring impacting significantly the path to desired success in larger public and professional interest. It is true that in the interest of profession and larger stakes of public health including the likelihood of adverse impact on the process of medical education inter alia resultant infliction on healthcare delivery system as a whole we are required to oppose certain health related laws and policies pertaining to medical education and public health. However, we need to build an image in the form of a Brand out of our creative well articulated documented ventures whereby the decision makers and the policy makers look upto IMA for consultation realizing that but for the same the optimization of decision making would not be feasible. IMA being the largest stake holder in the medical community of our country, it is in the interest of community and nation that we should be actively consulted and engaged before any law is passed or policy is made by the Government. This is a subtle policy in many developed nations like USA, UK where AMA or BMA have major say in preparing health laws and policies in view of the significant contribution in the form of required inputs provided for by the said associations and thereby establishing their credence and inevitable positioning whereby they stand invariably sought by any and every decision and policy maker independent of political hues and colourations.

To achieve and accomplish the aforesaid position we need to translate and set out the same into destined goals and thereby work out an blue print converted into an action plan to be executed in a concerted and consolidated manner. This would entail initiation of certain vital steps:-

- 1) Strengthen unity of the entire medical community under umbrella of IMA. Too much precious time and energy is squandered on small and petty things embroiling them into politics which has always turned out to be counter productive and contemptuous in nature and character. When we work in IMA sacrificing our practice and family time, we should make friends in IMA for espousing the larger cause by annihilating all that adversely impacts the medical profession and the professionals. As such our energies should be directed in fighting external threats not on our own brethren. It is important to rise above our own egos or narrow considerations of caste ,creed and religion and uphold the sole dictum that we are all linked by one thread that we all are doctors and our only religion is Humanity which is to be catered through our committed role and dispensation of responsibilities as Doctors.
- Connect with the community. IMA should and will engage with the community more and more by strengthening its various community health projects. By doing so the image of IMA and medical fraternity will get up scaled a lot improve a lot and dr - pt relationships will be far more conducive and congenial resulting in desired minimization of incidences of violence against doctors and resultant litigations. My emphasis will be on what our chief patron Dr. Ketan Desai has called to us - "Aao Gaon Chalen". We have plan to establish quality IMA hospitals in every district of the country for affordable quality treatment to poor and middle class people. Some of them may later be elevated to teaching institutions. Further if the general public is made aware that the issues which IMA is raising are infact concerning common man, and are in their interest and well being the entire population will be with us in their own interest and IMA being looked up as a pioneer and spear header for the same.
- 3) Collaboration with authorities. Persuasion and political liasoning and collaborating with authorities they be on more than one occasion turns out to be the easiest and handy way to achieve our goals. To confront all time, results in creation of a negativity which is invariably counter productive. Hence political liasoning will be strengthened at all levels of IMA. No doubt that when the need arises we will confront and agitate against any government for any and every wrong doing which would prejudice the interest of profession, professionals and

population at large. Our struggle against undermining modern medical sciences, mixopathy, crosspathy and quackery in any form will be more aggressive. The CPA need not to include medical professionals as assured by the government in the parliament. We demand amendments in impractical and anti doctor provisions in Central CEA 2010, PCPNDT and other Acts. Many states have made security acts for medical & health professionals. We urge all states to make it more stringent. IMA has already demanded a strigent Central Protection Act with minimum 10 years Jail punishment and its inclusion in CrPc.

4) Horizontal and vertical integration within IMA. Real strength of IMA is in local branches. We need to empower, strengthen, recognize and connect with them. So many of our IMA branches are doing extraordinarily wonderful work. Unfortunately other branches are not aware of it. Hence a mechanism will be created so that local and state branches can cooperate and replicate the good work. Also all this community work will be collaged and adequate publicity will be given to it. Real strength of IMA is in its local branches. Many a times common members and local branches are not even aware of the work done by state or national IMA. This communication gap between local, state and national IMA will be ameliorated.

HEALTH FIRST Campaign. As doctors our prime responsibility is towards maintaining health of common man of our country. If India has to become a superpower, each and every citizen of our country should have affordable, accessible and available quality health care. A campaign will be launched to make Health as Basic Fundamental right enshrined in our constitution and thereby urging the Government to upscale the public health through 5% of the GDP allocation to it in every financial year.

The efforts to make BRAND IMA a Academic brand will also continue and will be strengthened, so as to bring in its fold the much needed and required tenets through a three pronged approach of "Quality sustenance, Quality enrichment and Quality enhancement in an open ended manner through creating standing mechanisms on the basis of the sole Governing Dictum that 'Quality is a journey and not a destination'.

Women and young Drs now form the majority of medical profession. The focus will be to further empower and strengthen them so that their legitimate expectations that they rightly and richly deserve are catered to in a cogent, credible and a meaningful manner so as to entitle them with esteem dignity, self respect and well deserved honor.

Covid 19 has taught us many lessons. IMA needs to adopt to the NEW NORMAL way of functioning. Digitalization, newer platforms of communication and effective but judicious use of social media is the key, which would be evolved through structured time bound plans with appropriate budgetary outlay. Modern medical professionals and HCWs both from government and private sectors have given supreme sacrifices fighting Covid-19. Their dependents must be given benefits of insurance scheme (50 Lakhs) under PM Garib Kalyan Yojna.

Steps will be taken for increasing productivity and welfare of our own staff members by invocation of appropriate and commensurate capacity building initiatives and corresponding measures thereto.

IMA will be celebrating its centenary year in 2028. We need to start planning for a grand yearlong celebration right from now, so as to commemorate it in a mode and manner which would be inspiring in nature and reflecting in character. By 2028 I propose that IMA AKN Sinha Institute shall be elevated as a Deemed University with all academic works done by other wings under it. I with pleasure announce that a IMA Centenary Committee will be formed under our supreme leader Dr. Desai sir.

Friends I appeal to you all to join hands and work for IMA whole heartedly. There is so much work to be done in IMA that we need several hands to cater to the same rather than it turning out to be a monopoly of few. I urge upon all of you just to tell us your field of interest, we will not only entrust that responsibility but also empower you as I trust and belief in more the merrier approach.

Hon'ble Supreme Court of India's Interim Order dated 7.01.2022

The Court passed an interim order with the following directions:

- 1. We accept the recommendations of the Pandey committee that the criteria which has been stipulate in OM 2019 (for EWS) be used for 2021-2022 in order to ensure that the admission process is not dislocated.
- 2. Counselling on the basis of NEET PG 2021 and NEET UG 2021 shall be conducted by giving effect to the resolution as provided by the notice dated 29 July 2021 including the 27% reservation for OBC category and 10% reservation for EWS category in the All India Quota seats.
- 3. The criteria for determination of the EWS notified by OM 2019 shall be used for identifying the EWS category who appeared for Neet UG and Neet PG 2021 examinations.
- 4. The validity of the criteria determined by the Pandey committee for identifying the EWS prospectively for the future be subject to the final results of the petitions.
- 5. The petition shall be listed for final hearing on the validity of the EWS criteria as recommended by the Pandey committee in the third week of March 2022.

Dear Sir,

Admissions to medical PG courses has been indefinitely delayed and more than a year has passed without admitting a single candidate to medical post graduate courses. As you are already aware this is due to setting up EWS quota for medical postgraduate courses and subsequent court interventions.

Medical postgraduate training is an important factor in healthcare delivery. Without timely and appropriate postgraduate training quality healthcare cannot be imparted to the deserving population. Moreover, during their period of training, they form a major work force in delivering medical care, especially in tertiary centres. During the COVID pandemic also, their services were of paramount importance.

It has also been very painful to note that the striking junior doctors were subjected to harassment and assault by the police in the capital city. This police action has occurred when the doctors of the country where demanding for a central law to protect them from hospital violence.

In this context we request urgent intervention by the government to:

- 1. In view of past problems faced in the "Management of COVID 19" and "increasing Omicron cases", early intervention to conduct counselling for postgraduate courses and start admissions for the batches for the last year as well as the current year.
- 2. To bring a central law against violence in healthcare in lines with the draft law published by the government in 2019 and the provisions in epidermic diseases act amendment 2020.

We request your good self for an early intervention and urgent action.

Around 2000 doctors died during the second wave of COVID. The mortality rate in the country was around 1.5% among the general population and around 2-3% among healthcare workers. According to this estimate, corona occurred in about 100,000 doctors.

Mortality in the third wave is expected to be low but the Omicron variant is 5.4 times more infectious than the delta variant and due to the high exposure of Healthcare to Covid patients in clinics and hospitals, doctors are expected to have 5 to 10 times more Covid infections than the general public. In many big medical colleges/hospitals of the country have large number of medical staff, especially doctors, have been found infected. So that the health infrastructure can crumble due to the shortage of sick doctors.

In such a situation, the Indian Medical Association (HQs.) wants to suggest to the State Governments or the Central Government associated with the concerned medical college, so that the safety of doctors from infection can be ensured to a great extent, because doctors are the backbone of Indian health services in the pandemic.

- 1. The Covid duty of resident doctors should not exceed 8 hours per day and 7 days, after which there should be a quarantine of 10 to 14 days in the accommodation prescribed by the hospital.
- 2. There should also be a provision for taking care of their mental health.
- 3. In the event of a Covid duty doctor becoming ill, government/private hospitals should be admitted to the respective hospital at the earliest.
- 4. In case of untimely death, the status of covid martyr and compensation as well as, case wise assistance should be arranged.

Consequent upon the same the Ministry of Health and Family Welfare filed a detailed Affidavit before the Hon'ble Supreme Court cataloging various reasons including all those that were advocated by the National President leading the delegation and presenting the detailed memorandum thereto.

It is heartening to note that the said initiative duly responded by the Ministry of Health and Family Welfare, Govt. of India has paid dividends in terms of Hon'ble Supreme Court in terms of its pronouncement today dated 7th January, 2022 has paved the way for commencement of the counseling for admissions to postgraduate courses in terms of the notification made by the competent authority in July, 2021, which brings out a huge sigh of relief for all the junior doctors in the country and also to the healthcare delivery system in the country in this hour of poignant need.

Greetings from Indian Medical Association!

This is in continuation of our request to the Chairman, National Medical Commission through our letter dated 31.7.2021 requesting him to take prompt attention in conferring the pending Dr. B.C. Roy Awards for the last four years. (Copy enclosed).

This is just to remind you that in order to commemorate the fond memory of legendary Freedom Fighter and Bharat Ratna Late Dr. B. C. Roy, an Endowment Trust came to be constituted whereunder the Awards in different categories have been worked out. Honourable Prime Minister on Doctors' Day address highlighted the altruistic contributions of Dr. B. C. Roy, in whose remembrance the Doctors' Day is celebrated, and in his honour, the meritorious services of doctors are awarded.

In terms of the composition prescribed for the said Endowment Fund, President, Medical Council of India (Ex-Officio) and Secretary, Medical Council of India (Ex-officio) are the Chairman and Secretary of the said Endowment. However, the Indian Medical Council Act having been repealed by the National Medical Commission Act, 2019 and in terms therein National Medical Commission having been put into operation, the Chairman of the National Medical Commission and Secretary thereto are the Ex-Officio President and Secretary of the B. C. Roy Memorial Endowment Fund with Life Members in other categories thereto.

The doctors eligible for this award were annually selected by the Endowment Fund Committee and the selected doctors were bestowed with this title by His excellency the President of India.

In terms of the prescribed procedure, the Awards have been conferred by the Medical Council of India till the year 2017, however, since the supersession of the Medical Council of India in September, 2018 that came to be replaced by the Board of Governors and finally constituting the National Medical Commission in terms of National Medical Commission Act, 2019 in the year 2020, till date the said awards have not been conferred. Resultantly, as on date, the awards for four years which are required to be conferred annually have accumulated and are pending per se as it is.

The reasons for no initiative by the concerned including the present National Medical Commission is difficult to swallow and hard to digest because apart from the fact that the deserving are not being awarded by the prestigious award, but in a way even the very purpose of the creation of the Endowment Fund and thereby catering to the cause of commemoration of the memory of greatest modern medicine professional of India is also kept in limbo which is not only tragic but is heavily unfortunate too.

Hence, in the interest of all concerned including a humble salutation to the commemorative memory of Late Dr. B. C. Roy, Indian Medical Association beseech the proactive initiation from the Chairman, National Medical Commission and the concerned authorities at its earliest, kindly call for nomination and award this privileged and prestigious award for our medical fraternity.

In this Covid-19 Pandemic, the services of these doctors were well appreciated and they need recognition. During this Covid pandemic, the entire fraternity, right from the day one had involved in the war against corona from the front line to save millions of people from the clutches of severe covid-19. Many of our doctors, during the 1st and 2nd wave of Covid-19 Pandemic, have sacrificed their lives while serving the citizens of this country.

SUBJECT: -REGARDING DISCUSSION IN THE MEETING CONVENED BY THE HON. MINISTER WITH THE EXPERT DOCTORS WITH REPRESENTATION OF IMA THEREAT ON 11TH JANUARY, 2022 AT 11.30 A.M.

Respected Sir,

In continuation of the observations of the undersigned that were made in his capacity as the National President Indian Medical Association on behalf of IMA, I am pleased to pen down following lines for your consideration and required action thereon.

It is brought out in terms of the scientific evidence through various scientific studies that Omicron variant of Covid-19 causes milder disease which is specially evident from the studies made at Denmark, Scotland and South Africa respectively. Resultantly it is also observed that the same has resulting in lesser need for –

- Hospitalization a)
- b) Oxygen requirement
- Intensive Care Units c)

It is also fortified in terms of the reduction in Global Fatality Rate which as of now is less than 1%.

I also intend to bring to your knowledge and notice that research studies extensively carried out in Denmark have brought out that two doses of Pfizer vaccine has resulted in only 20% of effectivity in preventing Omicron however, booster dose of Pfizer vaccine results in generation of 80% effectivity. This is attributable to augmentation of neutralization efficiency invoked by the booster dose.

It is worthwhile to note that Denmark is the country where as of now 80% of the total population is double vaccinated and 50% of the population has received booster dose (Preventive Dose). It is also brought out categorically through various scientific research studies that past infection does not rendered any type of protection against Omicron infection. The reinfection rate of Omicron is palpably 5.4 times more than the Delta variant and their lies the real threat.

In the context of aforesaid scientific data it is worthwhile to note that two important things emerged out of it with reference to effective Covid management specially with reference to Omicron variant and they are:

- 1. It be propagated across with focus and intensity that 'if you get flu like symptoms assumed that you have Covid unless proven otherwise by RTPCR Test'. This will go a long over in tiding over the tackling efficacy against Omicron as a realistic awareness slogan.
- 2. In view of the efficacy as is evident by the Booster (Preventive Dose) of Pfizer Vaccine in terms of the studies referred to above and the same vaccine is in vogue in India the intensity of vaccination for third dose must be promoted and augmented in a very strong manner.

I thought it imperative to bring out these suggestions for your kind consideration to be appropriately availed in larger National and public interest with reference to effective and efficacious Covid Management with reference to Omicron variant.


