### From the desk of National President, IMA

Dear Friends.

Respected Sir / Madam,

Greetings from Indian Medical Association!

The entire medical fraternity is looking forward for your kind intervention in following important unsolved issues affecting the medical professionals directly and the general public indirectly.

1. Central law against violence in healthcare establishment and Doctors: IMA has been pleading with the Government to enact Central law against violence in healthcare establishment and Doctors since 2015. At the behestof the then Hon'ble Minister of Health & Family Welfare, Shri J.P. Nadda, a committee was constituted representing all concerned Ministries. The Health Ministry, in principle, had agreed on the proposed draft prepared by IMA. However, the law is yet to be taken up for formal implementation.

There are a number of incidents where the doctors are being physically harmed by the patients and relatives. Under these circumstances doctors have become more defensive in their medical practice and at loss to understand whether to entertain the serious patients or not. The situation needs immediate attention on priority so that the medical service continue uninterrupted.

Recently the Chief Justice of India has also shown his concern over increasing incidences of violence against doctors.

IMA once again requests you to use your good office to enact Central Law against violence in healthcare establishment and doctors.

- 2. CPA: Health services were wilfully excluded from the ambit of CPA 2019 after detailed debate in the Parliament and intervention of the then Hon'ble Minister of Consumer Affairs Late Shri Ram Vilas Paswan in 2019. But the exclusion is not explicitly mentioned in the said act. The representation was submitted to Hon'ble Minister of Consumer Affairs, Shri Piyush Goyal after personally meeting on 2.2.2022. We humbly request you to take up this matter on priority with the concerned Ministry.
- 3. Death due to medical negligence: The guidelines as proposed and adopted by the Ethics Board of National Medical Commission, as per directions issued by the Hon'ble Supreme Court of India need to be incorporated in the Criminal Procedure Court (IPC). The Indian Medical Association which was part of the Task Committee constituted by the then President, MCI (Now NMC) has proposed new Section 304C in PIC new Section 427 A in IPC to enable the Govt to implement the recommendations of the Task Committee effectively. In this regard, we have submitted the representation to your goodself too.

Further, we request you issue directives to all the State Governments to follow Supreme Courts' Guidelines to conduct an enquiry before filing an FIR in cases of Medical Negligence, and also not to invoke IPC Section 302 in cases of deaths during treatment.

4. Mixopathy: The Notification of CCIM dated 19.11.2020 has created confusion not only among the medical doctors practising modern medicine but also among the public. IMA has been requesting the Ministry of Health & Family Welfare as well as National Medical Commission to take necessary steps so that the curriculum of modern medicine shall not be converted into Mixopathy.

Sir, we request your intervention in this matter to enforce the NMC to maintain the purity of Modern Medicine and allow the other streams of Ayush grow independently.

- 5. CHS Doctors issue regarding enhancement of age of retirement: Though the Government has enhanced the age of retirement up-to 65 years, the doctors are not allowed to continue in administrative posts. As a result, a large number of doctors remain redundant in their departments. It is proposed that these doctors should continue in the administrative posts till the age of retirement.
- Draft Regulations of licence to practice in India issued by National Medical Commission (NMC): We

would like to draw your attention on the Draft Regulations of licence to practice in India as placed by National Medical Commission in public domain for comments. IMA has gone through in detail and discussed this issue in our appropriate forum and feels that the proposed Draft Regulations is defective, plagued by inconsistencies, arbitrariness and aims at annihilating not only the authority of the State Medical Councils but also to make them look puppet in the hands of Ethics and Medical Rating Board in NMC by divesting them of their core authority of registering medical professionals in the concerned States, maintaining State Medical Register thereto, and incorporating additional qualifications thereunder. It is, therefore, requested that Draft Regulations be put on hold and reviewed as per the suggestions already issued by IMA to NMC on 25.4.2022.

- 7. Upgradation of security services in various Govt. Hospitals: We have been noticing frequent incidents of violence and riot-like situations in public hospitals where the workload of the doctor is very high especially in emergency services, maternity services and intensive care services. Most of the time the patients are brought at the end stage where the doctors collectively are not in a position to save their lives. Such situations frequently cause unrest among the patient's relatives and incites violence. The security provision through contractual services is quite inadequate as they are not trained enough to handle such emergency situations. It is, therefore, requested that Central Industrial Security Force (CISF) who are capable of handling such grave situations need to be deployed in the Hospitals. A directive from the Ministry to all the State Governments is required, so that such practices are followed across the country uniformly.
- Indian Medical Services (IMS):

Uniformity in health services across the country is necessitated due to various National Health Schemes. National Health Mission (NHM) was also created in 1995 to have uniform services in the patient care across the country. The present covid pandemic has once again proved the requirement of centralized uniform dictat for smooth and adequate discharge of health care delivery. Had it been Indian Medical Services during the Covid pandemic, the result of public healthcare delivery would have been more effective and efficient. Apart from giving doctors their well-deserved role and responsibility in national building, it will be the appropriate answer to the current situation and a huge leap into the future.

Indian Medical Services was conceived during the British period and was approved under Section 312 of the Indian Constitution. The rules were also once notified but not implemented. Implementation of Indian Medical Services in line with other All India Group- 'A' services will make the healthcare care in different States inconsonant with the Central Guidelines.

Indian Medical Association has already submitted a detailed report on Indian Medical Services (IMS) prepared by the National Working Group in 2020. Earlier a Report of Study Group constituted by President, Medical Council of India in 2017 is also with Health Ministry for ready reference. IMA requests to take necessary steps to implement the Indian Medical Services based on these reports at the earliest.

GST Exemption for Healthcare Services: 47th GST Council meeting has recommended that "Like CTEPs, common bio-medical waste treatment facilities for treatment or disposal of biomedical waste shall be taxed at 12% so as to allow them ITC." This is to be effective from 18th of July 2022. This was earlier in GST exempted category.

47th GST Council meeting has also recommended that "Room rent, excluding ICU, exceeding Rs 5,000 per day per patient charged by the hospital will also be taxed at 5 per cent, without ITC." This is to be effective from 18th of July 2022. This was earlier in GST exempted category.

We, as collective voice of all establishments and doctors of the country express our serious concerns and objections to these new taxes in healthcare sector. This step will add big additional cost to the healthcare of people. We have already requested Honorable Minister of Finance and Chairperson, GST Council to withdraw any such step to levy GST on Healthcare Services. You are requested to convince the GST Council our concern in public interest.

Greetings!

As you aware that Government of India is committed from Malaria elimination i.e., achievement of zero indigenous case by 2030. Since 2015, India has made tremendous progress towards this goal. In comparison to 2014, by 2021, malaria cases and deaths have been reduced by 85% & 84% respectively. Country's progress towards malaria elimination have also been applauded globally in World Malaria Report 2018 to 2021, which is a proud moment for the country.

The progress has been possible by strengthening the program interventions i.e., early diagnosis & complete treatment, integrated vector management, monitoring and supervision. Private sector has contributed not only in Malaria elimination but overall health care system development. Efforts are also being taken to strengthen the engagement of private sector in Malaria Elimination programme as on many instances, private sector is the first point of contact for fever/Malaria cases.

33 States have mandated notification of Malaria cases (except Bihar, Meghalaya and A&N Island). National Center for Vector Borne Disease Control (NCVBDC), Dte. GHS, MoHFW is also in process of making Malaria centrally notifiable. For reporting from private sector, in imminent future, Integrated Health Information Platform (IHIP)-Malaria module is being expanded in the whole country, including private sector.

I take this opportunity to call upon Indian Medical Association (National & State chapters) to support the country in achieving the goal of Malaria elimination by:

- Notifying all the Malaria cases to State/District/local health services, so that appropriate public health actions can be taken at the earliest.
- To ensure that correct /updated SOPs for diagnosis and complete treatment are followed. Sensitization of medical practitioners in this regard should also be done.

I am confident that with the concerted efforts of Government of India, State Governments and professional bodies like IMA, we shall achieve the goal of Malaria Elimination by 2030.

### Hosp corporatisation denies healthcare access to poor: CJI

'Hefty Fees Have Marred Docs' Ties With Patients'

New Delhi: Highlighting the "growing and unchecked" corporatisation of the country 's health-care system, Chief Justice of India N V Ramana on Tuesday said the profit-driven approach of hospitals denies the poor access to healthcare and exorbitant cost charged by them forces people to suppress their treatment needs and well-being.

Addressing doctors of the National Academy of Medical Sciences (NAMS), the CJI also appealed to the governments to take measures to stop brain-drain in the medical field as many doctors are shifting to foreign countries because of better facilities and working environment. Referring to various incidents of medical practitioners being attacked and abused during the pandemic, he said doctors must be provided a



False cases are being lodged against upright and hard-working doctors, CJI N V Ramana said on Tuesday and decried assaults on them

safe environment and governments must work on it.

"One trend that needs discussion is the growing and unchecked corporatisation of our healthcare system. Private hospitals are being opened at an exponential rate. This is not necessarily a bad thing, but there is a glaring need for balance. We are seeing hospitals being run like companies, where profit making is more important than service to society. Due to this, hospitals had discovered towards the plight of patients. They are just numbers

for them. This trend has also spread monopoly and is deepening the inequities in access to health care." CJI Ramana said.

He said there has been growing distrust among the common citizens towards doctors and hospitals and "hefty fees, chaotic experiences, and sub-par service has marred the relationship between doctors and the general public".

"Especially in a country like In-

"Especially in a country like India, where there is immense disparity in access to healthcare, doctors are accountable to the public.
Exorbitant medical fees coupled
with excessive barriers has made
it almost impossible for the poor to
get decent healthcare. It is primarily the cost of healthcare that is
forcing people to suppress their
health care needs and well-being.
The heart-breaking fact is that, the
crucial preventive stage is often
lost when people suppress their
health needs," he said.

"During the pandemic I saw various instances where doctors had been threatened, abused, attacked, and shumed. Despite this, they continued working on the front lines. They need a better; and more secure, working environment," Justice Ramana said.

वह ठीक कर देंगे ?कोर्ट ने कहा, ऐसा लगता है कि एलोपैथी का मजाक उड़ाया जा रहा है। इसके साथ ही कोर्ट ने केंद्र और अन्य को नोटिस जारी कर जवाब मांगा है। दरअसल, कोर्ट इंडियन मेडिकल एसोसिएशन की एक याचिका पर सुनवाई कर रहा है। एसोसिएशन का आरोप है कि देश में टीकाकरण अभियान और एलोपैथिक दवाओं के खिलाफ अभियान चलाया जा रहा है। इससे पूर्व दिल्ली हाई कोर्ट ने भी रामदेव को एलोपैथी के खिलाफ बोलकर लोगों को गुमराह नहीं करने की सलाह दी थी।

### SC raps Ramdev for deriding allopathy, docs

New Delhi: The Supreme Court on Tuesday told the Centre that Baba Ramdev and his ayurveda venture Patanajali must be restrained from making false claims about curing incurable diseases and publishing ads disparaging the allopathy system of medicine and doctors, reports Dhananjay Mahapatra. "Ramdev should not criticise other medicine systems and accuse allopathic doctors as killers. This is impermissible," the SC said.

Appearing for petitioner Indian Medical Association, advocate Prabhas Bajaj presented a chain of ads issued by Patanjali making false claims about finding cure for Covid-19, high BP and asthma, which is punishable.

### IMA seeks withrawal of 5% GST on health sector

A delegation will meet Prime Minister, Finance Minister and Minister for Health soon, says its national president K SRINIVASA RAO VIZIANAGARAM

Indian Medical Association (IMA) national president and member of National Medical Commission, Sahajanand Prasad Singh has urged the Centre to withdraw 5% GST on the hospital room services, saying that it would put additional burden on the patients.

In an exclusive interview to *The Hindu* over telephone from New Delhi, Dr. Singh said that GST would be a big burden on hospitals as they had already been facing many financial problems with the steep hike in maintenance costs due to upward revision of rent, electricity charges, salaries of doctors and staff.

Established on December 28 in 1928 in Calcutta (now Kolkata), the IMA is the premier body for doctors. It has four lakh members across India. The association plays a key role in bringing the issues of medical fraternity to the notice of the government. IMA is strongly opposing 5% GST on hospital room rents, exceeding ₹5,000 per day per bed without giving Input Tax Credit (ITC).

Dr. Singh said that a highlevel delegation of the IMA would meet Prime Minister Narendra Modi, Finance Minister Nirmala Sitharaman and Union Minister for



GST is a burden as hospitals are facing problems in the wake of hike in maintenance cost, says IMA national president Sahajanand Prasad Singh.

Health and Family Welfare Mansukh Mandaviya soon, seeking GST exemption and other issues pertaining to the healthcare sector.

"Healthcare industry is in a deep financial crisis with the unprecedented maintenance cost. At this juncture, the government's support is needed. We are hopeful that the government would respond positively over the issue of GST exemption," he added.

### Mixopathy

Dr. Singh said that more than 10 lakh doctors across India were worried with the proposal of mixopathy for which the Central Council of Indian Medicine had issued a Gazette notification recently.

"The government's permission to Ayurvedic doctors to perform 58 allopathy surgeries will lead to many health complications of patients. The line of clinical management of medical and surgical procedures are completely different although pre-clinical subjects are the same for Ayurveda and Allo-

pathy," Dr. Singh pointed out.


Dr. Singh also expressed concern over the violence against the doctors and attacks on hospitals.

He further said that the doctors' services should not be kept under the purview of Consumer Protection Act (CPA) since medical negligence can be confirmed by experts.

### Executive body meeting

"IMA's national executive body will discuss all issues in a conference scheduled to be held in Allahabad on December 26, 27 and 28. We will invite Ministers too to the meeting to enable them to know the grievances of the healthcare sector. We hope that the issues will be resolved with the constant persuasion with the policymakers," he added.
